**QUALIFICATIONS:** Applicant must possess a high school diploma or GED if applicant has previously held a classroom/bus aide position. New applicants who have not held the position of a classroom/bus aide must possess a two-year associate degree or equivalent or attain a passing score on the School Service Personnel Performance Test for Aide.

**ASSIGNMENT:** Tend to hygienic and instructional needs of special needs student(s). Aide provides personal care services and must ride school bus and supervise child/children, if necessary. Must be able to lift student (in excess of fifty pounds) to assist with hygienic needs.

**SALARY:** State Minimum Salary
