Call to Order.

MINUTES...

On the motion of Mr. Burns and seconded by Mr. McComb, the Board unanimously approved the Minutes from the Board of Education meeting held on March 30, 2021.

AGENDA...

On the motion of Mr. Burns and seconded by Mr. McComb, the Board unanimously approved the agenda. Mr. McComb requested an Executive Session to be held after Matters of the Board on superintendent's evaluation, goals, and personnel issues, no action taken.

DELEGATIONS...

No delegations were requested.

SUPERINTENDENT'S REPORT & SPECIAL RECOGNITION...

Superintendent Beam opened the session by honoring school bus operator, Donald McNeel, as Pocahontas County Service Person of the Year and ELA Math Coach, Stephanie Burns, as Pocahontas County Teacher of the Year. The tributes are well deserved.

Though it is not feasible for a large ceremony due to COVID-19 social distancing guidelines, Mr. Beam indicated that each school will host an individual Super Scholars awards ceremony this year. 201 Super Scholars trophies will be presented across the county. Once principals finalize their end-of-the-year plans and confirm dates, Mr. Beam would be honored to present the trophies at each program.

As we prepare for the 2021-2022 school year, Mr. Beam informed the Board that we will soon be hiring after school program teachers, academic interventionists, and parent/family involvement coordinators for

the upcoming year. Also, we may be adding a supper feeding program to the schedule and hire evening cooks.

Mr. Beam instructed that though we are experiencing “mask fatigue” it is imperative that we follow the guidelines in the Re-Entry Plan. He also reminded principals that recreational field trips are absolutely discouraged this year. Only in-county trips necessary for class requirements will be permitted.

Mr. Beam updated the Board with on mediation with attorney Henry Wood over reclaiming the loss of state funds. Financial Commissioner ordered the state to negotiate in good faith. Both the Mr. O'Dell, mediator, and Mr. Wood did not feel the state was negotiating as ordered. Mr. Beam will continue to inform the Board of the logistics.

Unfortunately, the School Building Authority did not award Pocahontas County any SBA funds this time. We can apply again in November. Currently, counties that were closing schools in the flood plain areas were granted funds. ESSERF Competitive grant should be used for windows, doors, and HVAC. We must address funding for the Marlinton Elementary School's sprinkler system, furnaces and roof. These repairs are vital.

INFORMATIONAL REPORTS/CENTRAL OFFICE UPDATES...

- a. Alan Gibson, Student Representative. Spring sports are underway and doing great at PCHS. The unveiling of the 2020-2022 Above the Influence Warriors' poster is scheduled at 8:15 AM tomorrow.
- b. Johnathan Paul, Derek Trull, and Lois Wilfong, Community in Schools—Programs don't change people, relationships do. Each coordinator highlighted relationships with students, families, and local communities. Projects include enabling effective family communication, monthly to-go bags, high tunnel improvements, prom, and a suitcase drive. Additionally, CIS has worked to improve reading scores by providing big student incentives. It proves an asset to Pocahontas County Schools.
- c. Ruth Bland, Multicultural Plan— We must familiarize ourselves with different cultures with respect to their beliefs, without biases or prejudices. Though not publicized, some schools are doing a very good job. Currently, we are forming committees to help design the plan, structuring multiculturalism and social justice with policy 2510 and policy 2520.19. The first meeting will be May 5, 2021 at the Board Conference Room. Plan will be a work in progress. Principals are encouraged to include individuals with different opinions in order to have well-rounded committees.
- d. Sherry Radcliff, COVID grants PowerPoint—In an informative presentation and handout, Mrs. Radcliff discussed the CARES grant funds, ESSERF Competitive grant funds and the allowable expenditures of each, including maintaining the federal and state required guidelines
